1 During the period of 6-9 August 2012, 3GPP2 TSG-S Plenary conference calls that were held in
 2 conjunction with the 3GPP2 super-meetings in Seattle, WA, USA. This document is intended to
 3 summarize those proceedings.

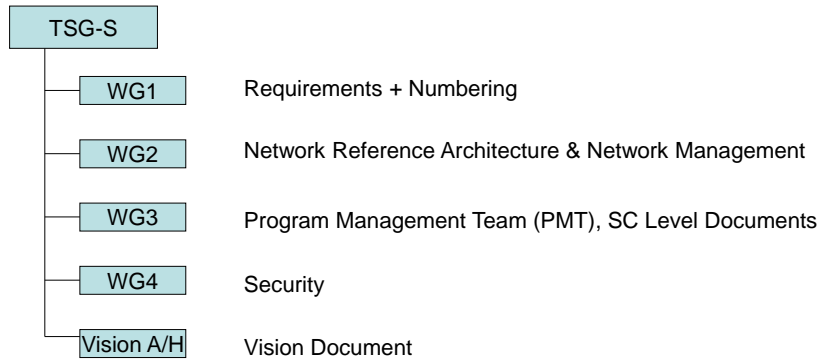

- 10 consensus on high level Restructuring scheme. General conclusions are as follows:
- 11 • Favorable and general support for proposals for merging TSG-A and TSG-C, and
- 12 • TSG-S and TSG-X as presented in the 2 contributions.
- 13 • Proposals aligned well with associated TR-45 subcommittees (TR-45.4, TR-45.5,

- 16 • identify documents as they are in present TSG structure
- 17 • Gameplan for SC/OP approval and implementation
- 18 • Present the TSG restructure proposals to the respective TSGs during the 6-10
- 19 • August meetings in Seattle.
- 20 • Plan conference calls as needed after the August meeting to continue work with
- 21 • TSG members on restructure.
- 22 • Continue discussion during October 3GPP2 super meetings.
- 23 • Present proposal for 3GPP2 Restructure to 23 October SC meeting and seek

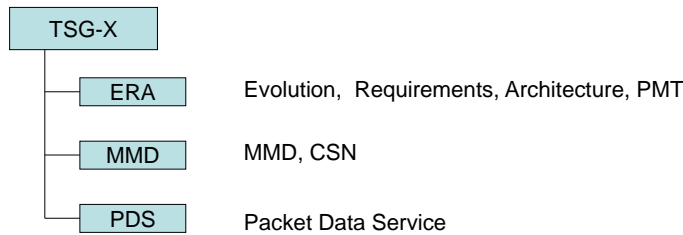

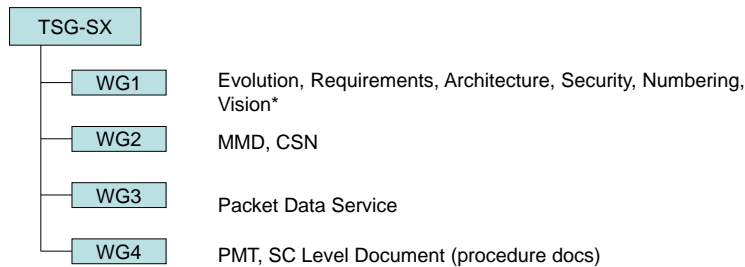
