In order to ensure that the UIMID is always used, the UIM\_ID usage indicator would always need to be set to use the UIMID. There will be further discussion of the proposal. A correspondence to TSG-S will be drafted for the opening plenary of the December meeting. An informal description of the concern noted above was provided to the TSG-S WG1 Chair.
