9.1 ITU-R M.1457-12 Either Meeting "X+2A" or "X+2B"

The timeframe during which the list of specifications to be included in the M.1457-12 update will need to be provided to the ITU in either "X+2A" (February 2014) or "X+2B" (June 2014). In addition, each Partner will need to sign a copy of Certification Form B, as provided in SC-20130916-009r1.

- > SC-20130916-008, the TR-45 report, included additional information and was provided FYI.
 - "The schedule for revision 12 updates to M.1457 (IMT-2000) was reviewed. There was lengthy discussion regarding the deliverables for meeting "X+1" (October 2013) and either meeting "X+2A" (February 2014) or "X+2B" (June 2014). It was noted that the GCS Proponents need to select either meeting "X+2A" or "X+2B". Based on the TR-45 meeting's deliberations, it was agreed that meeting "X+2B" in June 2014 is preferable due to the 3GPP2 meeting schedule for 2014 (see attached). TR-45.5 continues to provide updates to M.1457 relative to CDMA-MC. TR-45.3 continues to work jointly with ATIS WTSC on M.1457 updates to TDMA-SC."
