OPENING PLENARY

1. TSG Opening Remarks by TSG Chairman – The Access Network Interfaces TSG (TSG-A) meeting was opened on Monday, October 24, 2005 at 8:38 AM local time by George Turnipseed, Chair.

2. Introduction and Attendance Registration: The Chair conducted the roll call of participating Individual Member (IM) companies. Fifteen of the 16 quorum members were noted as present, constituting 94% quorum.

At the September TSG-A meeting, it was noted that ZTE Corporation would be dropped from the quorum list due to two consecutive missed meetings. However, the Chair directed that ZTE Corporation remain on the quorum list in light of unfortunate circumstances preventing their attendance.
