• HRPD Revision B

The initial V&V period for HRPD Revision B documents was set for a comment due date of 7 May 2006, along with an interim plenary conference call to receive the comments on 8 May 2006. However, TIA balloting on these two documents started on 10 April, so in order to receive both the 3GPP2 and TIA ballot comments together, the V&V period was extended until 10 May 2006. The interim plenary conference call was then re-scheduled for 15 May 2006, at 6:00pm Central Time USA (note that the first part of the conference call will be used to receive all comments, and the second part of the conference call will be used to conduct a preliminary V&V AdHoc meeting). During Opening Plenary, Scott Marin of Motorola was selected to serve as the AdHoc chair for these documents. The Secretary took an action to send out a notice on the new interim plenary date and time, as well as an announcement regarding the modified V&V due date.
