17 **Abstract:**

18 This document is a summary of the 3GPP2 TSG-C meetings that were held during the period of
19 16-20 April in Chicago, IL, USA.

1 During the period of 16-20 April 2012, 3GPP2 TSG-C meetings were held at the Hyatt Regency
2 Chicago Hotel in Chicago, IL, USA. This document is intended to summarize those proceedings.

4 **OPENING PLENARY**

5 **1. CALL TO ORDER AND OPENING REMARKS:** The meeting was called to order on
6 Monday 16 April 2012 at 10:24 AM local time by TSG-C Chair, Ed Tiedemann (Qualcomm).

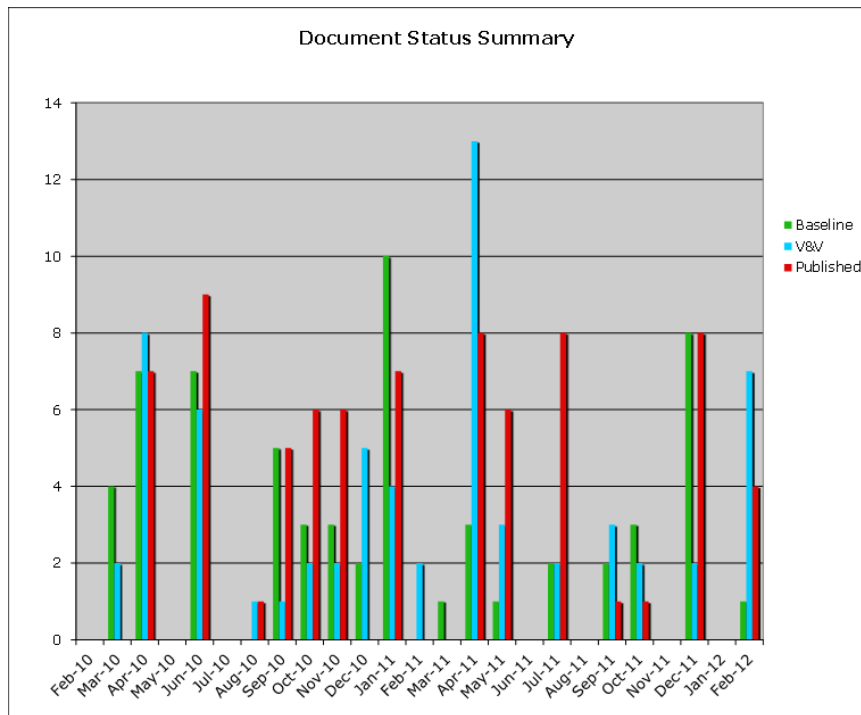
