1 During the period of 31 March – 3 April 2008, 3GPP2 TSG-S meetings were held at the Delta Centre-Ville in
2 Montreal, QC, Canada. This document is intended to summarize those proceedings.

4 OPENING PLENARY

5 1. CALL TO ORDER AND OPENING REMARKS: The meeting was called to order on 31 March 2008
6 at 1:19 PM local time by TSG-S Chair, Nick Yamasaki (KDDI).

7 The Chair welcomed everyone to Montreal and requested that they introduce themselves.

8 The meeting participants were requested to sign-in electronically using the server sign-in facility.

9 2. ATTENDANCE REGISTRATION AND ROLL CALL: A roll call of companies indicated that 9
10 companies included on the list of 16 active quorum members were present (56% participation). Thus,
11 meeting quorum was achieved.

12 The Secretary noted that no proxy statements had been received for this meeting.

13 3. INTRODUCTION AND NUMBERING OF CONTRIBUTIONS: Contributions were loaded onto the

15 required as an output of this meeting for meeting planning purposes. In addition, since the OPs
16 must consider the outputs of the May 2008 Workshop, the workload projection would not be
17 finalized until later. He suggested that the output could be carefully worded to reflect this
18 concern.
