This document provides the summary of the 3GPP2 TSG-S meetings held at the Kyoto International Conference Center in Kyoto, Japan during the period of 3/21-24/00.

During the period of 3/21-24/00, a meeting of 3GPP2 TSG-S was held at the Kyoto International Conference Center in Kyoto, Japan. This report is intended to summarize those discussions.

OPENING PLENARY

The meeting was called to order on 3/21/00 at 8:55 AM local time by TSG-S Chair, Hideo Okinaka (DDI).

- The Chair welcomed the group to Kyoto, former capital of Japan.
- A roll call of TSG-S active companies indicated 13 companies in attendance out of 23 active companies (57% participation). Thus, meeting quorum was achieved.
- All contributions were distributed as soft copy only.
- The proposed agenda (3GPP2-S00-20000321-001) was reviewed and approved without objection. These contributions were numbered and assigned to agenda items.
- The meeting summary for 2/00 in San Diego, CA (3GPP2-S00-20000321-002) was presented and approved without objection as submitted.

CORRESPONDENCE

 All discussion on received correspondences were deferred until the applicable agenda item.

LIAISON REPORTS

- 3GPP2 SC: No recent meetings.
- TSG-A: The TSG-A meeting summary for meeting #11 (3GPP2-S00-20000321-011) was presented as FYI. That report included an indication that both IOS v4 and TFO were in ballot resolution.
- TSG-C: On schedule for approval of all Release A and cross mode documents at the opening Plenary of the Cheju, Korea meetings on 3/27/00.
- TSG-N: No report.
- TSG-P: No report.
- TSG-R: Not currently active.
- TR45: A summary of the 3/00 TR45 meeting in Vancouver, BC (3GPP2-S00-20000321-023) was presented as FYI.
- TR45 ISD ADHOC: A conference call was held to resolve discrepancies in the TR45 3G Workplan. The results were presented in the TR45 meeting. Still unresolved is the issue of documents from 3GPP being balloted by the TR45 TDMA community.
- TR45.7: No report.

- TR45 NAG: The NAG Liaison Report was presented verbally as FYI.
- TR45 AHAG: The AHAG Liaison Report (3GPP2-S00-20000321-003) was presented. They have evaluated the AKA algorithms and have found no major short comings with that technology. The issue of compliance with global challenge operations of ANSI-41 systems is still under review. A correspondence to other TSGs was assigned for presentation at the closing Plenary, as well as final acceptance of the TR45 ESA strategies, where these issues will be discussed.
 - AHAG will not review KASUMI since it is not in compliance with their "publicly available" requirements. AHAG will support SHA-1.
- ITU-T: The submission of the SCG as the Q.1701 supplement (3GPP2-S00-20000321-010) was presented as FYI. This document included a request to review of section 9.2 (Family Member) by the PMT and to generate appropriate correspondence to ITU-T SG11 with a TSG-S position.
- ITU-R: ITU-R WP8 did meeting this month but no detailed information was available for this meeting.
- OHG: An open letter to SDOs from the OHG (3GPP2-S00-20000321-009) was presented as FYI. This letter noted that it had formalized its charter to develop IMT-2000 technology for global 3G wireless networks. Professor Michael Walker (Vodafone-AirTouch) has been named as the first Chair of this group.

• OLD BUSINESS:

• APPOINTMENT OF WG1 CHAIR: Based on the resignation of John Visser (Nortel Networks) as WG1 Chair, the TSG-S Chair appointed Nick Mazzerella (Lucent) as the new WG1 Chair, effective as of the next TSG-S meeting in 4/00. Scott Migaldi (Motorola) was appointed to replace Nick as the WG2 Vice Chair.

WG1 ISSUES:

- Correspondence dated 3/15/00 from the TSG-N-3GWIN WG regarding Release B RUAC Current Calling Party Feature (3GPP2-S00-20000321-017) was remanded to WG1 for action as appropriate by the closing Plenary.
- A proposed Stage 1 description for "Location Information Restriction" service (3GPP2-S00-20000321-008) was presented. This contribution indicated a need to protect location information while also being responsive to FCC E911 mandates. This document was remanded to WG1 for action as appropriate by the closing Plenary.
- Correspondence dated 3/15/00 from the TSG-N-3GWIN WG regarding Release B LSSS Feature (3GPP2-S00-20000321-016) was remanded to WG1 for action as appropriate by the closing Plenary.

 Discussion on the proposed network architecture model for Location Based Services in packet switched networks (3GPP2-S00-20000321-021) was deferred pending the attendance of the contributor.

This contribution was later presented and reviewed in detail by the contributor. This document was remanded to WG2 for review and suggested actions as appropriate.

WG2 ISSUES

- NRM changes developed by the TR45 NAG AdHoc proposed for revision B (3GPP2-S00-20000321-004) in response to the 3GPP2 requests. One (1) of the considerations which was raised in the NAG meeting was the acceptability of a layered approach for the NRM. This document was remanded to WG2 for action as appropriate by the closing Plenary.
- Correspondence dated 3/15/00 from the TSG-N regarding their review of the NRM (3GPP2-S00-20000321-015) noted no comments and was remanded to WG2 for action as appropriate by the closing Plenary.
- Correspondence dated 2/17/00 to TR45 from TR45.7 regarding TR45.7 operational concerns (3GPP2-S00-20000321-005) was presented as FYI.
- Correspondence dated 2/24/00 to T1M1 from TR45.7 regarding 3G Stage 2/Stage 3 cooperation (3GPP2-S00-20000321-006) was presented as FYI.
- A standards overview of 3GPP SA WG5 (3GPP2-S00-20000321-022) was presented and remanded to WG2 for review and action as appropriate by the closing Plenary.

PMT ISSUES

- Correspondence dated 2/16/00 from TSG-A regarding their review of the 3GPP2 Point Release Discussion Paper (3GPP2-S00-20000321-007) was remanded to the PMT for action as appropriate by the closing Plenary.
- Correspondence dated 10/18/99 from TSG-N regarding their review of the 3GPP2 Release B Workplan (3GPP2-S00-20000321-012) was remanded to the PMT for action as appropriate by the closing Plenary.
- Correspondence dated 2/16/00 from TSG-A regarding their review of the 3GPP2 Release B workplan (3GPP2-S00-20000321-018) was remanded to the PMT for action as appropriate by the closing Plenary.
- Correspondence dated 3/18/00 from TSG-N delivering their negative response to the proposed Documentation WG (3GPP2-S00-20000321-013) was remanded to the PMT as FYI.

• Correspondence dated 3/18/00 from TSG-N regarding their comments on the master 3GPP2 work item list (3GPP2-S00-20000321-014) was remanded to the PMT as FYI.

• NEW BUSINESS:

• Motorola and Nokia submitted a proposal to add very high rate, mixed voice and data transport as a 3GPP2 work item (3GPP2-S00-20000321-020) to be added as a part of Release A-2. The details of this strategy were overviewed in a presentation on this subject (3GPP2-S00-20000321-019). NOTE: The presentation included a copyright statement and reservation of rights included. Both Nokia and Motorola verbally indicated that the 3GPP2 copyright statement was applicable to these contributions and that these rights were superseded by the 3GPP2 copyright statement. This presentation was presented as FYI.

The group approved a new work item to the 3GPP2 Workplan called "Enhanced 1x solution for high speed packet data". This capability would be described as follows: "cdma2000 systems provide high-speed forward and reverse link wireless access in a fixed as well as in a mobile environment. The current cdma2000 specification needs to evolve and should have a migration path to achieve higher packet data rates while maximizing the capacity of the system in a 1x environment."

The PMT Chair was remanded the task of generating correspondence to the other TSGs advising them of this new work item and requesting their immediate attention on this subject. In addition, the input of each TSG will be solicited regarding service requirements for this platform.

The Plenary was recessed on 3/21/00 at approximately 2:55 PM local time.

CLOSING PLENARY

The Plenary was reconvened at 3:35 PM local time on 3/24/00 by TSG-S Chair, Hideo Okinaka (DDI).

- Quorum had been established at the opening Plenary and was not challenged at this session.

 - WG1 Report (3GPP2-S00-20000321-041) was presented by WG1 Chair, John Visser (Nortel Networks) as FYI.

- Generated proposed correspondence to all TSGs regarding the Stage 1 descriptions for video streaming and video conferencing (3GPP2-S00-20000321-047). Attachments to this correspondence will include the following:

 - Proposed modifications to ANSI-664

This correspondence was approved without objection for transmission pending confirmation of the referenced document number included therein.

- Generated proposed correspondence to TSG-N WIN TG transmitting the revised LBSS Stage 1 (3GPP2-S00-20000321-049). This correspondence was approved without objection for transmission pending the completion of the edits to the LBSS Stage 1 document.
- Generated proposed correspondence to TR45.2 WIN WG providing TSG-S comments on the LIR (location information restriction) Stage 1 (3GPP2-S00-20000321-050). This correspondence was approved without objection for transmission as modified by the discussion.
- Generated proposed correspondence to all TSGs delivering the 3GPP2
 acronym list (3GPP2-S00-20000321-051). The acronym list will be attached.
 This correspondence was approved without objection for transmission as submitted.
- WG2 Report (3GPP2-S00-20000321-042) was presented by the WG2 Chair, Masaaki Yoshimura (Hitachi) as FYI.
 - Approved baseline text for the 3GPP2 NRM for Release B as received from the TR45 NAG AdHoc. A layered NRM will be considered for Release B but no action has been currently committed. Generated proposed correspondence to all TSGs to distribute the NRM baseline document (3GPP2-S00-20000321-004). The baseline NRM (3GPP2-S00-20000321-044A) will be attached. This correspondence was approved for transmission without objection as modified by the discussion.
 - Generated proposed correspondence to 3GPP TSG-SA WG5 regarding potentials for unification of 3G OAM&P requirements (3GPP2-S00-20000321-052).
