During the period of 4/25-28/00, 3GPP2 TSG-C meetings were held at the Four Seasons Hotel in Seattle, WA. This document is intended to summarize the proceedings.

OPENING PLENARY

The meeting was called to order at 10:30 AM local time on 4/25/00 by TSG-C Chair, Jean Alphonse (GTE Wireless).

- The roll call of companies indicated that 29 companies already included on the list of 36 active members were present and thus quorum was established (81% participation).
- The proposed agenda (C00-20000425-001) was presented and approved without objection as submitted.
- Contribution register was noted (C00-20000425-000R1). Contributions were numbered, distributed, and assigned to agenda items.
- The meeting summary from the 3/00 meetings in Cheju, Korea (C00-20000425-002) was presented and approved without objection as submitted.
- An unofficial summary of the 4/19/00 3GPP2 SC meeting in Vancouver, BC (C00-20000425-003) was presented as FYI.
 - This contribution was remanded to WG1 and all 1x enhancement adhocs as FYI.
 - The IETF Report (C00-20000425-004) was remanded to WG1 for action as appropriate.
 - All 1x enhancement adhocs were requested to prepare an executive summary by the closing Plenary. The Chair direction for preparation of a comparative matrix from the last Plenary was withdrawn.
 - The IOTA Stage 1 and Stage 2 (C00-20000425-005) was remanded to WG1 and WG2 for comment.

CORRESPONDENCE

- The Liaison statement from ITU-R TG 1/5 regarding unwanted emission limits (C00-20000425-009) was presented as FYI.
- The ITU-R WP 8F Liaison Statement for RSPC revision (C00-20000425-008) was presented as FYI.
- The meeting summary of the first ITU-R WP 8F meeting (C00-20000425-007) was presented as FYI.

These contributions (C00-20000425-007, C00-20000425-008, and C00-20000425-009) were all remanded to WG3 and WG4 as FYI.

- Proposed revisions to technical report Q.FSR (C00-20000425-011) were presented as FYI. This contribution was remanded to WG2 for action as appropriate.
- The supplement for Q.1701 framework from ITU-T (C00-20000425-011) was presented as FYI. This document was remanded to WG2 as FYI.
- The Abis specification (C00-20000425-014) was presented as FYI.
- The 3GPP2 workplan v16+ (C00-20000425-018) was presented and remanded to WG1 for review and comment as appropriate.
- Correspondence from TSG-P to TSG-A regarding QoS support for packet data (C00-20000425-012) was presented and remanded to WG1 as FYI.
- Committee correspondence from TSG-P regarding IP data broadcast and multicast services (C00-20000425-013) was presented and remanded to WG1 as FYI.
- A contribution from Sprint PCS requesting the addition of IP data broadcast and multicast services to the Release B workplan (C00-20000425-020) was presented and remanded to WG1 for consideration and action as appropriate.
- A proposal for idle mode acquisition of digital signal from analog mode (C00-20000425-017) was presented and remanded to WG1 for consideration as a part of the Release B workplan and to WG2 and WG3 as FYI.

OLD BUSINESS

- A summary of the 1xtreme AdHoc meeting in Cheju (C00-20000425-021) was presented as FYI.
- A summary of HDR call flows (C00-20000425-019) was presented and remanded to the HDR AdHoc for consideration and action as appropriate.
- A summary of benefits of LAS-CDMA (C00-20000425-022) was presented and remanded to the LAS AdHoc for action as appropriate.
- A list of requirements for 1x enhancements (C00-20000425-023) was presented and remanded to the WG1 for review.
- The leadtime requirements for V&V on Release B activities (C00-20000425-015) were presented as FYI. This issue will also be discussed at the Chairman's meeting.
- LIAISON REPORTS None additional.
- NEW BUSINESS None additional.

The meeting was recessed on 04/25/00 at 11:30 PM local time.

CLOSING PLENARY

The Plenary was reconvened on 04/28/00 at 2:45 PM local time.

- The Chair noted that this was the last day for WG2 Chair, Kim Chang (Nortel Networks), who was assuming other responsibilities within Nortel Networks and he thanked Kim for his great service. Orlette Pearson (Lucent) was appointed as the new WG2 Chair.
- CORRESPONDENCE none
- WORKING GROUP REPORTS:
 - WG1 REPORT (C00-20000425-101) was presented by the WG1 Chair, Phil Brown (Ericsson), as FYI.
 - SMV codec selection as completed. SMV6 from Conexant was selected as the baseline SMV codec which will be used as the focal point of a collaboration effort to generate a final codec design. This effort will be limited to 6 months. At this time, there is no plan to make a back-up selection.
 - Held preliminary review of video services Stage 1 documents and possible selection of default codecs for the video and supporting audio. There were also some discussions regarding the error resilience of the RLP layer as it relates to video services and QUALCOMM agreed to do some testing related to this issue.
 - Correspondence to TSG-S regarding the NRM indicating no TSG-C issues or concerns (C00-20000425-112) was developed. This correspondence was approved without objection for transmission with a minor correction to the Chair's e-mail address.
 - A review of the IOTA documents with respect to IS-683-A is in process.
 - The new role of SMG9 was reviewed and response correspondence will be generated at the next meeting.
 - Initial discussions of TSG-C Release B workplan issues were held but primary discussions were deferred until the next meeting when the CDG SRD on cdma2000 air interface enhancements could be considered.
 - Proposed publication text for C.P1001-A (TSB-58-C) (C00-20000425-110) was presented. This document was approved for publication without objection.
 The Chair will liaise this to all OPs.
 - The TSG-C Release A specification list v3 (C00-20000425-111) was presented as FYI.
 - The WG1 Chair will develop a proposal for a TSG-C document management system to be submitted for consideration at the next meeting.

- Two (2) TSG-C PN numbers were requested to develop specification text for video conference and streaming services including the identification of codecs and definitions of associated service options. Impacts to lower layer facilities will be addressed in other documents (i.e., MAC, LAC, or whatever). These projects were approved.
- An additional PN was requested for minimum TTY performance specification.
 There was some concern expressed regarding whether WG1 or WG4 should
 handle this item based on scope and charter definitions. The Chair directed that
 WG1 would handle this issue in consultation with WG4 as required and the
 request for PN was approved.
- WG2 REPORT (C00-20000425-102) was presented by WG2 Chair, Kim Chang (Nortel Networks), as FYI:
 - Resolved all ballot comments for IS-2000-1. A draft was submitted to WG3
 for review and their comments were also incorporated. The document was
 liaised to TR45.5 for action.
 - Reviewed Stage 1 descriptions for video services and no issues or concerns were identified at this time but the documents are still open for consideration.
 - Reviewed IOTA and determined no impact. However, IS-683-A may be impacted but this must be reviewed by WG1.
 - WG2 workplan discussion will be held at the next meeting and all WG2 participants have been asked to prepare for these discussions.
- WG3 REPORT (C00-20000425-103) was presented by WG3 Chair, Ed Tiedemann (QUALCOMM):
 - Received a draft of IS-2000-1 from WG2. WG3 changes were incorporated and the document was approved from a WG3 perspective.
 - Reviewed the 3GPP2 SCG provided by TSG-S and provided comments (C00-20000425-113). These comments will be included in the Liaison Report to TSG-S.
 - Generated list of new features being planned for Release B for incorporation into the TSG-C workplan (C00-20000425-114) but no action from the Plenary was required at this time. Since the Release B schedule is still in process, the schedule for submission of new concepts for Release B to the next meeting.
 - The Chair noted that, during the next meeting, the CDG SRD will be available for review and the TSG is expected to finalize its workplan for Release B at that time.

- Proposed requirements for enhancements for cdma2000 air interface from China Unicom (C00-20000425-023) were presented. The contribution had been previously remanded to WG 1 for review. The contributor was reminded the contribution should be submitted to TSG-S. The Chair also indicated that TSG-C will be developing its own technical requirements.
- WG4 REPORT (C00-20000425-104) was presented WG4 Vice Chair, by Dave Whipple (Agilent Technologies):
 - Spent time reviewing and approving a multitude of meeting summaries
 - IS-97 and IS-98 text development is in process. They have developed a strategy to complete all text with the exception of data table ASAP and submit that to V&V. Two (2) new service options will be added including TDSO (test data service option) and Markov.

• OLD BUSINESS

- 1XTREME ADHOC: The adhoc met and had technical discussions on the proposal and the executive summary of the 1XTREME proposal (C00-20000425-107) was developed. This executive summary was approved without objection for transmission to the SC Chair and copied to TSG-S as FYI.
- HDR ADHOC: The adhoc met and had technical discussions on the proposal (meeting summarized in C00-20000425-109) and the executive summary of the HDR proposal (C00-20000425-108) was developed. This executive summary was approved without objection for transmission to the SC Chair and copied to TSG-S as FYI.
- LAS-CDMA ADHOC: The adhoc met and had technical discussions on the proposal and the executive summary of the LAS-CDMA proposal (C00-20000425-106) was developed. This executive summary was approved without objection for transmission to the SC Chair and copied to TSG-S as FYI.
- Since the 1XTREME ADHOC was the only group the kept to the one (1) page restriction that was initially imposed by the Chair, the Chair agree that language would be included in the cover letter explaining the reason for the limited input from that group and advising that a more detailed summary would be developed at a future meeting.
- The cover letter will also indicate that the executive summary were produced by the adhoc's and have not been reviewed for technical completeness or consistency by TSG-S and do not represent the position of TSG-C. The cover letter will be broadcast to the TSG e-mail exploder.
- A conference call of the TSG-C leadership will be held on 5/25/00 to discuss the CDG air interface enhancements SRD.

- Oki Telecom expressed concern that the TSG-C Chair has specified his intention to develop requirements within TSG-C based on the following issues:
 - Duplication of effort with TSG-S
 - Going beyond the charter of TSG-C
 - Poor definition of the difference in requirements being developed by TSG-C and TSG-S

The Chair indicated that TSG-C would not generate requirements but only attempt to align requirements which it reviews in support of the TSG-S requirements development function.

- The Chair also indicated that he has requested that all persons who participated in the development of the CDG SRD to be present at the next TSG-C meeting.
- The publication of the 3GPP2 Release A documents which include the TIA ballot resolutions will be completed at the opening plenary of the next meeting.

NEW BUSINESS

• A preliminary draft of the year 2001 schedule was posted to the server.
